

# SAF INTEGRAL GUARANTEE Conditions

# The guarantee conditions for brake discs on the SAF INTRADISC *plus INTEGRAL* suspension unit 9t from delivery date 01.06.2003 onwards:

SAF-HOLLAND GmbH, Hauptstrasse 26, 63856 Bessenbach/Germany, known in the following as SAF-HOLLAND, provides as manufacturer with respect to its customers, irrespective of any contractual guarantee rights, and in addition to the SAF-HOLLAND Guarantee of Competence, the following manufacturer's guarantee for the INTRADISC *plus INTEGRAL* suspension unit, also with respect to the end customers, both termed here as "beneficial owner":

## Content of the guarantee

SAF-HOLLAND guarantees the beneficial owner a service life of 3 years from the initial registration or 500,000 km, whichever comes first, for 22.5 inch brake discs without continuous cracks occurring in the brake discs. Similarly with 19.5 inch brake discs, SAF-HOLLAND guarantees the beneficial owner a service life of 2 years from the initial registration or 350,000 km, whichever comes first, without continuous cracks occurring in the brake discs. If after changing brake discs an extension of the guarantee period for these brake discs arises due to new guarantee periods, then the *INTEGRAL GUARANTEE* also ends after 6 years from the initial registration of the trailer/semi-trailer.

Continuous cracks are cracks running from the outer edge of the brake disc through to the inner edge of the brake disc. The guarantee does not include spider web-like cracks or cracks running towards the middle of the hub up to a width/depth of 1.5 mm which are not regarded as serious according to TÜV criteria.

If a change of disc is required due to continuous cracks, then the guarantee comes into force.

In this case SAF-HOLLAND accepts the costs for the material of the brake disc up to a maximum of the relevant applicable German SAF-HOLLAND spare parts gross price list plus any transport costs incurred by the return of the replaced brake discs. Labour and workshop costs for removal and installation are not included in the guarantee.

# Transferability of the guarantee

In the event of a sale of the trailer/semi-trailer by the beneficial owner, prior to expiry of the guarantee, said guarantee automatically transfers to the new owner. It is not necessary to inform SAF-HOLLAND of the change in ownership. However the beneficial owner is required to inform the new owner of said guarantee.

#### Prerequisites for guarantee services

The trailer/semi-trailer must be equipped with an electronic braking system (EBS) which is fully operational and without fault. In the case of a guarantee claim and on request from SAF-HOLLAND, the beneficial owner will supply SAF-HOLLAND with the operating data stored in the EBS system. SAF-HOLLAND shall be entitled to read and analyse the "Operating Conditions Protocol" from the EBS brake system of the trailer/semi-trailer.

The beneficial owner must inform SAF-HOLLAND of any change of disc within three weeks, stating the new brake disc numbers and must make the removed brake discs and brake pads available to SAF-HOLLAND on request.



## Exclusions

Normal wear, damage to the brake disc due to the effects of external force, operating faults, use in racing or military applications and damage resulting from the failure to observe the operating instructions, maintenance and installation instructions or from the use of spare parts not approved by SAF-HOLLAND are excluded from the guarantee.

Claims for damages of any sort are excluded. This exclusion does not apply to liability for losses due to negligence with injury to life, body or health or for other losses which are based on a gross negligent or deliberate breach of duty.
