## Service Bulletin - December 2023 SAF Tire Pilot Plus™ (TPP) Inflation System



### Tire Pilot Plus Recall Reactivation/ Upgrade

# Electronic Controlled Module (ECM) controlled systems only

In response to Safety Recall 23E-045, ECM controlled Tire Pilot Plus (TPP) systems, sold between December 1st 2022 and June 15th 2023, have been determined under specific conditions to slowly deflate the trailer tires. A TPP system upgrade is now available that accounts for these conditions and allows the system to function properly. This document will help you identify which kit to use for your specific trailer configuration and if a new module is required. To fully implement the upgrade you will also need access to a mobile device with the TPP App installed. The App is available on the Apple Store and Google Play.

# Tire Pilot Plus Inspection and Reactivation Process

#### **INSPECTION:**

- Check the trailer build date on the VIN tag. If it was manufactured December 2022 or later, the trailer could be in the target group, but needs to be confirmed to have the electronic regulator assembly installed.
- 2. **Figure 1** illustrates the electronic regulator. Location is on the front cross-member for a sliding suspension.
  - a. This recall does not include TPP systems with the mechanical regulator installed *(Figure 2)*.
  - b. Some trailers may have the electronic regulator already removed. If the regulator is not installed the TPP system is not part of the recall. A replacement kit will need to be purchased. See replacement kit selection on page 2.
- Units that have already been reactivated will have yellow decals affixed to the control module as well as yellow marked tire hoses installed (Figure 3).
- 4. Before performing any inspection on the trailer, set the parking brake and block the tires.

#### **▲**WARNING

Failure to set the parking brake and chock the tires prior to beginning maintenance could allow the vehicle movement which, if not avoided, could result in death or serious injury.
