### **Purpose and legal basis of the data processing**

SAF-HOLLAND GmbH processes all collected personal data in accordance with the requirements of the European General Data Protection Regulation (GDPR) and the German national law (Bundesdatenschutzgesetz – BDSG). The data processing is based on the following demands and purposes:

#### **Consent, Art. 6 para. 1 lit. a GDPR**

The concrete purpose of the data processing will be communicated to you in the respective declaration of consent (for example newsletter subscription). You have the option to revoke this consent at any time.

**Contractual and legal obligation, Art. 6 para. 1 lit. b, c GDPR**

Furthermore, we process personal data for the fulfillment of legal obligations or contracts. The concrete purpose is based on the respective law or contractual relationship.

**Legitimate interest, Art. 6 para. 1 lit. f. GDPR**

Finally, we process your personal data in individual cases only if we have a legitimate interest in the processing of personal data and do not outweigh your interests or fundamental rights and freedoms.

**Data transfer to third parties in and outside of the European Economic Area (EEA)**

As part of a global corporation, personal data may sometimes be transferred to other companies of the SAF-HOLLAND SE Group or to other service providers inside or outside of the EEA. In the case of a transfer, the commissioned companies will use your personal data for the same described purposes and according to the same European law as the SAF-HOLLAND GmbH does. The transmission to third countries outside of the EEA is subject to the standard contractual clauses in accordance with EU Commission Decision 2010/87/EU or a successor version.

**Affected rights, Art. 15 ff. GDPR**

As a user of this website, you have a right to free information about the stored personal data, their origin, their recipients and the purpose of the storage as well as a right to rectification, data portability, restriction of processing and erasure. Please note that we cannot erase your data in any case, but for example only if the purpose of the data processing is omitted and there is no statutory storage requirement.

In order to exercise your rights, an informal notification to your direct contact person at SAF-HOLLAND GmbH or to the above-mentioned data protection officer is sufficient. Please let us know which information or processing activity your request relates to, the format in which you wish to receive this information and whether the personal data should be sent to you or to another recipient.

**Right to complain to a supervisory authority, Art. 13 para. 2 lit. d GDPR**
